2004 Annual Meeting

The Carriage Trails
Homeowners Association Annual
Meeting was held at 7:00pm April
22, 2004 at North Ridge
Community Church. Fifty-five
ballots were represented in
person, mail-in ballot, or by proxy,
with approximately one dozen
homeowners in attendance.



The 2003-2004 Board of Directors Annual Report was read, and included the following:

- The website was finalized and expanded;
- New landscape & lighting was added to the Scottsdale Road entrance;
- Two ballot questions were presented to homeowners regarding: 1) the possible revision of the rear-yard Policies & Guidelines, and 2) the expansion of the commercial vehicle definition. Both ballot questions failed to receive the necessary 67 votes for passing;
- A Committee was formed to research improvement of the Dixeleta and Scottsdale Roads intersection, as well as along Scottsdale Road; and
- The installation of a 67th Street entrance median was researched and found to be too time consuming for the Board to address the issue at this time.

New House # Signage Policy

In response to homeowners who feel they need more visible house numbers than currently allowed (the small plaque attached to the garage), the following list of guidelines has been developed by the Architectural Committee. The CC&Rs do not allow additional signs, however they do give the Architectural Committee the authority to establish acceptable criteria that would allow their use. It is believed that these guidelines will fit most signs that have already been placed by homeowners thus minimizing any retrofit that may be necessary. Done

properly such signs would be an attractive addition to the community as well as making it easier to find houses. These guidelines will provide some consistency for their use and appearance in the neighborhood. The Carriage Trails Board has recently approved these guidelines. While approved, any such sign would still require the approval of the architectural committee, however any sign that meets all of the guidelines can be approved immediately by the chair of the committee.

Note that any existing signs <u>are not</u> grand fathered since they were not allowed or approved in the first place, however no association action will be taken against homeowners with such signs if they submit their request for approval to the architectural committee within 30 days of this notice. A request form is attached to this notice. Again, any signs that meet the guidelines below will be approved immediately while others would have to be approved by the whole committee and therefore could take longer. The goal is to insure that any such sings are in character with the neighborhood and are an attractive addition, while not violating the CC&Rs. The following provides information regarding the new House Number Sign Guidelines:

- Size: The sign should be no larger than 20" high x 36" wide and 6" deep.
- Material & Color: The sign should be made out of sandstone, tan in color.
- Lettering: The sign should contain the street number of the house as the major feature with letters (numbers) 5 to 7 inches high. All lettering should be dark brown to black, for contrast to and compatibility with the tan sandstone. The letters/numbers may be recessed if desired.
- Options: The family name of the residents may be included in smaller letters of the same color.
 - Designs: Small designs compatible with the character of the community, such as desert animals, plants, etc. may be included so long as they are not a dominant part of the sign.
 - 2. Placement: The sign should be no closer than 8 feet to the curb so it is out of the right-of-way and presents no hazard. It should be along side the driveway or walkway in front of the house so it is easy to find. It should be placed so as to be visible when approached from either direction on the street, unless placed on a lot on a cul-de-sac or street with no other access in which case it can be angled toward the normal direction of incoming traffic. The sign shall be held in place or supported using boulders or large rocks to appear more natural.
 - 3. **Illumination:** If lit for visibility at night, the light shall be ground mounted, completely shielded, and pointed

at the sign so no light is visible off the property. The wattage of the light shall be 30 Watts or less. Another option is to highlight the numbers with a thin stripe of reflective paint (yellow or orange preferred) for night visibility without the use of lights.

Expanded Color Pallet Update

For homeowners who might be planning on repainting their homes in the near future, you may wish to wait because another ballot will be coming out in the near future about the expansion of the current paint pallet to add some darker colors!

Currently we have very little variation in the five approved house colors, and this will be an opportunity to have more color variety. Any proposed new colors will conform to the latest requirements for the North Scottsdale area, which is a Light Reflective Value (LRV) of 35% or less.

Brush/Bulk Trash Collection

A few homeowners are continuing to place yard waste out for pick-up long before the scheduled pick-up date.

Because this compromises the



appearance of our community, we are enforcing the City's Nine-Day Rule of not placing items out for pickup more than nine (9) days prior to the scheduled pick-up date. The Carriage Trails Pick-Up Schedule is listed below:





The gray areas of the Carriage
Trails Subdivision map are
designated by the City of
Scottsdale as "NAOS," which
stands for the words "Natural
Area Open Space. In
accordance with the Scottsdale
Environmentally Sensitive Land
Ordinance, these areas must
remain and be maintained in
their state as natural desert.

It is absolutely in violation of the Scottsdale Ordinance — and thus unlawful — to pile trash or plant clippings in it, ride bikes or motorized vehicles in it, build anything in or upon it, dig up the plants (or plant any new plants), or even remove dead plant material from any portion of the NAOS.

In short, the NAOS is off limits — and must remain that way — to eliminate possible damage and/or liabilities which could be incurred. By a Covenant that appears on each of the recorded Carriage Trails Subdivision maps, the responsibility for the maintenance of all of the NAOS is specifically imposed upon the Carriage Trails Homeowners Association. That's us — all of us — and if a Carriage Trails homeowner or a member of his or her family violates the law and damages the NAOS by doing something in the NAOS that is against the law, it is up to the Homeowners Association to fix it — and it's the offending homeowner that will have to pay for it. It would be entirely unfair to all of the other members of the Association — and that's all of us who own homes in Carriage *Trails* — *if the unlawful actions* of any single homeowner should be permitted to impose this cost upon the rest of us... so please remember to treat the NAOS

with care.
