## Vehicle speeds

Carriage Trails has no sidewalks, and also has streets that make frequent turns. Since there aren't really any places to walk or for children to play, other than in the streets, it is really important that everyone who drives in the community drive slowly and is constantly on the lookout for people walking with or without their dogs and kids playing. Please take it slowly and be on the lookout for walkers, and also alert anyone you know who will be driving in our community to do the same. The health and safety of our residents depend on it.

## Dogs

A lot of us own dogs, there is truly no better companion. However lately, there have been a number of dogs in the community that are not on a leash and there has also been a proliferation of dog droppings, both in the NAOS and on homeowner's lots. Both the city and the county require any domestic pet to be on a leash when off the owner's property and picking up after your dog is also a requirement. Allowing your dog to run off leash exposes them to the many dangers in the desert, including snakes, Javelina, and coyotes, not to mention all the plants with thorns.

We appreciate those homeowners who follow these rules and would hope that everyone would do the same as a courtesy to all other
homeowners, if not for the safety and welfare of your own pet.

## Residiential Brisi Renoval

Please remember that the City of Scottsdale has enacted a Brush/Bulk Trash Collection Ordinance asking residents not to place bulk or brush items out for collection more than two weekends (or nine days) prior to the Monday of the scheduled pick-up. The purpose of this Ordinance is to alleviate blight in our neighborhoods. With this thought in mind, the Association is asking homeowners to not place bulk/brush items in front of your property any sooner than 9 days before the scheduled pickup.
